**Narrative:**

On Tuesday, February 24, 2026, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Douglas Burke (Burke) responded to 10810 Brookpark Rd., Brooklyn, OH for an Officer-Involved Critical Incident (OICI) involving officers from Parma Police Department (PPD). The OICI happened within the city of Brooklyn, OH and BCI had been requested to investigate the OICI from Brooklyn Police Department (BPD). Throughout the investigation, it had been alleged that PPD Cruiser # [REDACTED] had been struck by gunfire from the involved subject, Ricardo Yuuki Davis (Ricardo), during the incident.

BCI's Crime Scene Unit (CSU) had also been requested by BPD. Crime Scene Special Agents (CSSA) Dave Hammond (Hammond) and CSSA Ed Lulla (Lulla) had responded to the scene. During the processing of the crime scene at 10810 Brookpark Rd., Brooklyn, OH, the alleged cruiser damage to PPD Cruiser # [REDACTED] from gunfire had been documented by BCI's CSU.

Later that date, SA Burke received a phone call from Lieutenant (Lt.) Patrick Suchan (Suchan) from PPD, the assigned liaison between PPD and BCI for the OICI investigation. Lt. Suchan stated the alleged damage to PPD Cruiser # [REDACTED] did not take place during the OICI and the damage had been caused by old damage from a prior incident. The old damage had been documented from September 8, 2024. Lt. Suchan sent documentation of the prior damage to PPD # [REDACTED], and the documentation is attached to this report.

SA Burke made CSSA Hammond aware of the documented prior damage to PPD Cruiser # [REDACTED].
