**Narrative:**

On Tuesday, June 11, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matt Collins (SA Collins) received requested records and recordings from Columbus–Division of Police (CPD) Sgt. Terry McConnell. The requested records were related to an Officer Involved Critical Incident (shooting) that occurred on June 10, 2024. Through an active MOU, BCI/SA Collins had previously requested all dispatch records, audio recordings (radio, 911, and phone), mobile data terminal (MDT) communications, and any other dispatch/communications–related information. As a result of that request, the following items were reviewed by SA Carrie Ryan:

**Computer Aided Dispatch (CAD) Records:**

The CAD records indicated:

- At 2316 hours, officers were dispatched to a man with a knife, described as a male White with brown hair, wearing jeans. Later, the subject was also described as a Hispanic male.
  - Several witnesses called in and the male's clothing description varied: wearing a green shirt and khaki pants; or wearing black clothing.
  - The male was reported jumping in the street, in a threatening manner with a knife, attempting to stop vehicles around the area of Georgesville Road and Clime Road. One caller stated they had to reverse their car to get away from the subject.
- At 2319 hours, the first officer arrived in the area.
- At 2322 hours, it was documented a caller advised the subject was 'acting stupid,' and provided a license plate of #JFX2798.
- At 2323 hours, a notation was made regarding the subject threatening people inside the Turkey Hill.
- At 2324 hours, a witness stated the subject left southbound and then northbound on Georgesville driving 'wrecklessly.'
- At 2325 hours, an officer noted the subject had a knife in his hand and was hitting his

- own vehicle with it.
- At 2325 hours, a 10-3 code was aired (Officer in trouble).
- At 2326 hours, S10C aired to 'try and spike it' referring to the vehicle.
- At 2328 hours, Officers aired the vehicle was driving on the wrong side of the road.
- At 2329 hours, CFD (Columbus Division of Fire) was notified.
- At 2329 hours, the location of the subject was aired at Industrial/Old Sullivant, along with 'shots fired...one down.'
- At 2330 hours, officer support was requested for five (5) officers, as well as the command bus.
- At 2349 hours, the subject was pronounced dead.

#### Radio Traffic Recordings:

Sgt. McConnell submitted two (2) audio files containing police radio traffic to SA Collins.

The files were titled based on the date and time of the totality of radio transmission, on two different radio channels:

 "PTAC\_3A\_2024-06-10\_at\_23.20.32\_thru\_2024-06-11\_at\_06.04.22"

#### Zone 3 Radio Traffic 2024-06-10 at 23.16.17 thru 2024-06-11 06.04.22 (Review):

*Other radio traffic transpired during this recording, unrelated to the incident in question. Unrelated radio traffic will not be detailed in this review.*

- Starting at 2316 hours, Unit # [REDACTED] was dispatched to a 10-33A (person with a knife) at Georgesville/Clime Roads. The dispatcher noted a male with long hair, wearing jeans, is reported running at vehicles with a knife. Unit #103 also marks enroute.
- At 05:30 into the recording, Unit # [REDACTED] marked in the area.
- At 07:10 into the recording, the dispatcher aired to Unit #103 and Unit # [REDACTED] (who were both in the area) that another call was received regarding the male, who came into the Turkey Hill threatening people. A male officer marked they copied (the unit number was inaudible).
- At 07:50 into the recording, Unit #103 marked that someone at the Turkey Hill reported the subject was a Hispanic male, wearing a green hoodie, and drove southbound on Georgesville Road in a green Hyundai. Unit #103 corrected himself and said the subject was wearing a green polo.
- At 08:12 into the recording, an officer marked the subject is northbound on Georgesville Road, driving recklessly. The officer tells Unit # [REDACTED] he is right behind the subject. Unit # [REDACTED] marks with broken radio traffic.
- At 12:52 into the recording, an officer aired "shots fired, shots fired." The dispatcher acknowledged and an officer said "one down."
- At 13:22 into the recording, an officer said "24" (code for medic) and the dispatcher noted CFD was already advised of the location at Industrial and Old Sullivant.
- At 13:46 into the recording, Unit #277 noted they would need a five (5) officer support as well as the command bus.
- At 18:15 seconds into the recording, an officer advised Franklin Twp. Medic is

- transporting one to Doctor's West in critical condition.
- At 34:10 into the recording, Unit #9150 aired the pronounced time of death was 2349 hours.

The remainder of the transmissions is related to additional officers' response, officer support, and command center organization.

PTAC 3A 2024-06-10 at 23.20.32 thru 2024-06-11 at 06.04.22 review

- At 08:58 into the recording, Unit #83 marked "on it."
- At 09:13 into the recording, Unit #S19 marked on "this."

The remainder of the transmissions is related to additional officers' response, officer support, and command center organization.

911 Calls:

There were four (4) total 911 calls provided to SA Collins. They appeared to be titled based on the date and time of the call. The calls were as follows:

*2024-06-10\_23.13.49\_Ch11797093:* An unknown male truck driver, named "Jack," reports a "nut case" is in the area of the Turkey Hill Market. Jack was unsure his location. Jack reported the subject was a White male, who has brown long hair, wearing jeans and was approaching vehicles in the street. Jack noted there was a lone vehicle in the parking lot of the Turkey Hill.

*2024-06-10\_23.14.41\_Ch11797096:*

A female who identified herself as "Tamera" reported, in the area of Clime and the Mount Carmel Health Center (later says Georgesville Road), a male is banging on doors of cars and making threats with his fists balled and trying to get in vehicles. Tamera could not understand the male because of broken English. Tamera noted he tried to get into to her vehicle, where her son was sitting. Tamera reported the subject is a "Mexican man" wearing a green shirt and khaki pants. Tamera further noted a semi-tractor trailer was stopped in the road and a green vehicle was pulled halfway into the Turkey Hill.

*2024-06-10\_23.14.51\_Ch11797107:* A female caller, who identified herself as "Sunur" reported a male with a knife is in the area of Georgesville and Clime Roads. Sunur reported he ran at her vehicle in the middle of the road and she had to put it in reverse to get away from him. Sunur described the male subject as White with a mustache, wearing black clothes. Sunur noted he approached two other vehicles and was banging on their vehicles, and they got away.

*2024-06-10\_23.20.26\_Ch11797159:* An unknown male calls in. He is unable to give his location; however, he offers a license plate #JFX8729. The male says he was in one area and then moved to another area; however, it was unclear on what details he was trying to report. The dispatcher kept asking him for his location and he said he could not give his location and hung up.

Other Phone Call (other than 911):

A recorded conversation from a Franklin County Dispatcher to a CPD dispatcher was provided to SA Collins.

**2024-06-10\_23.22.04\_Ch11797184**– Columbus Police Tech #105 answer a call from a female Franklin County Dispatcher who advised she took a knife run at the Turkey Hill (950 Georgesville Road). The dispatcher reported a male caller reported a subject walked into the store and was threatening people with a knife. The male caller disconnected and was unable to be reached by telephone. The dispatcher offered his number as: [REDACTED]

SA Ryan transcribed or documented what she believed was relevant, based on her knowledge of the case at the time of this report. Also, SA Ryan transcribed what she believed was being said during the communications. For these reasons, the reader is encouraged to listen to the communications for themselves and to develop their own opinion on both matters.

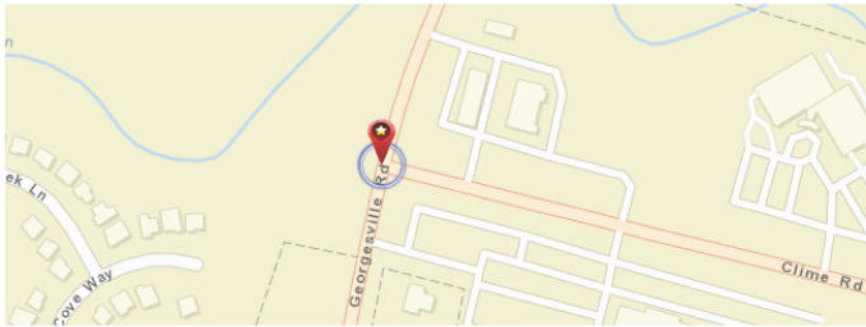
