Narrative:

On Monday, December 16, 2024, at approximately 1530 hours, the Ohio Bureau of Criminal Investigation (BCI) Crime Scene Unit (CSU) and Special Investigations Unit (SIU) responded to an officer-involved shooting which occurred at 3487 Belmont Avenue, Youngstown, Ohio, 44505.

Special Agent (SA) Chad Doran (Doran) collected the physical items of evidence from the crime scene. SA Matt Armstrong (Armstrong) collected [REDACTED]'s firearm and SA Fletcher collected the subjects clothing and personal items from Liberty Township Officer's at St. Elizabeth Youngstown Hospital.

All the items of evidence collected were turned over to SA Armstrong at the Liberty Township Police Department. SA Armstrong transported the evidence to the BCI Richfield office located at 4055 Highlander Parkway, Richfield, Summit County, Ohio 44286.

At approximately 2230 hours, the items were secured in BCI Temporary Evidence Locker #40 and the BCI Temporary Evidence Drying Room.
