Narrative:

On Wednesday, September 29, 2021, Ohio Bureau of Criminal Investigation (BCI) Special Agent Shane Hanshaw (SA Hanshaw) conducted a neighborhood canvass in the area of 2469 Kimberly Pkwy. E, Columbus, Ohio. The purpose for the canvass was to identify and interview potential witnesses to an Officer Involved Critical Incident, in the form of an officer-involved shooting, that occurred at 2469 Kimberly Pkwy. E, Columbus, Ohio on Wednesday, September 29, 2021. During the neighborhood canvass, SA Hanshaw made or attempted contact with the residents at the following addresses:

2469 Kimberly Pkwy. E, Columbus Ohio. Apartment #P7

On Wednesday, September 29, 2021, at approximately 1345 hours, SA Hanshaw attempted to make contact at Apartment #P7. No contact was made with any resident at this apartment.

2469 Kimberly Pkwy. E, Columbus Ohio. Apartment #P6

On Wednesday, September 29, 2021, at approximately 1345 hours, SA Hanshaw attempted to make contact at Apartment #P6. No contact was made with any resident at this apartment.

2469 Kimberly Pkwy. E, Columbus Ohio. Apartment #P13

On Wednesday, September 29, 2021, at approximately 1346 hours, SA Hanshaw attempted to make contact at Apartment #P13. No contact was made with any resident at this apartment.

2469 Kimberly Pkwy. E, Columbus Ohio. Apartment #Q2

On Wednesday, September 29, 2021, at approximately 1349 hours, SA Hanshaw attempted to make contact at Apartment #Q2. No contact was made with any resident at this apartment.

2469 Kimberly Pkwy. E, Columbus Ohio. Apartment #P12

On Wednesday, September 29, 2021, at approximately 1350 hours, SA Hanshaw attempted to make contact at Apartment #P12. No contact was made with any resident at this apartment.

2469 Kimberly Pkwy. E, Columbus Ohio. Apartment #P11

On Wednesday, September 29, 2021, at approximately 1351 hours, SA Hanshaw made contact with apartment #P11 resident, Zainan Adeyefo (Adeyefo). SA Hanshaw introduced himself to Adeyefo and requested any information that she might have regarding the OICI. Adeyefo was very reluctant to speak with SA Hanshaw regarding the incident. Adeyefo said she was a student in Columbus and did not know any of her neighbors. Adeyefo refused to give any of her personal information, including her telephone number. Adeyefo did state she heard three gunshots earlier in the day, but did not see or hear anything else. Adeyefo said she did not go outside of her apartment and does not have a window directed toward the location that the incident occurred. Adeyefo said she does not have any residential cameras and did not use her cellular telephone to record any part of the incident. Adeyefo said she has not been approached by anyone else regarding the incident.

2469 Kimberly Pkwy. E, Columbus Ohio.

On Wednesday, September 29, 2021, at approximately 1410 hours, SA Hanshaw spoke with Jose Rodriguez (Rodriguez). Rodriguez is a maintenance worker at the apartments located at 2460 Kimberly Pkwy. E. During the neighborhood canvass, two (2) hunting type trail cameras were located on the roof of the apartments in two (2) separate locations. SA Hanshaw was assisted by Rodriguez in retrieving the cameras.

Once obtained, SA Hanshaw examined the cameras. Both cameras were not operational. SA Hanshaw was advised the cameras were placed on the roof about one (1) year ago. Further inspection of the cameras revealed the four (4) AA batteries installed in the cameras were leaking and not operational.

Further information regarding the interview of Jose Rodriguez can be found in a report authored by SA Matt Collins. SA Hanshaw did not record his conversation with Rodriguez concerning the cameras.

The neighborhood canvass and interview conducted with Zainan Adeyefo was recorded. A copy of the recordings are attached to this investigative report.
