Narrative:

On Friday, January 16, 2026, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Allison Fletcher (SA Fletcher) compiled background information on Robert Riddlebarger (Riddlebarger), a subject involved in the incident on January 11, 2026. The information included researching past police reports involving the subject, searching criminal history records, court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit (CIU) and the Euclid Police Department (EPD).

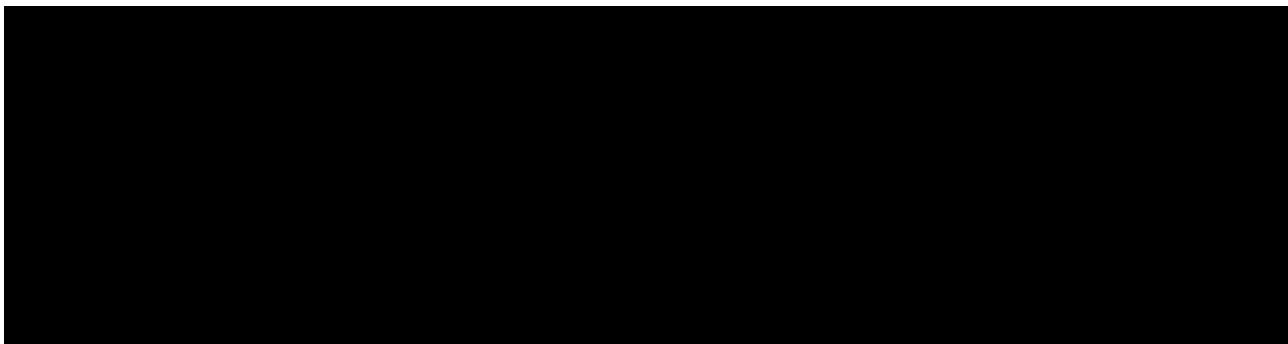
SA Joe Lamping (Lamping) reviewed the information and noted the following:

Prior Interactions with the Euclid Police Department:

Riddlebarger was involved in one prior incident with EPD on January 1, 2023. In the incident, Riddlebarger was listed as a victim. EPD Officer James Aoki (Aoki) handled the call for service. The incident was in regard to a former acquaintance of Riddlebarger being placed on a trespass list for Riddlebarger's property.

Computerized Criminal History (CCH) and/or Court Records:

Riddlebarger's CCH indicated several prior arrests related to crimes of violence. The nature and outcome of the arrests is documented on the table below:

Database Searches:

BCI CIU conducted a variety of database searches involving Riddlebarger. One of the searches revealed that Riddlebarger had been investigated for an assault while in the United States Army. The incident, which was reported to have occurred on November 5, 2008, was classified as a mutual assault in which Riddlebarger engaged in a physical altercation with another member of the United States Army.

Social Media Posts Related to Adams:

Riddlebarger's public Facebook page included various information in regard to his time in the United States Army. Riddlebarger listed that he was a member of the 27th Engineer Battalion as well as the 57th Sapper Company. He also posted various photos alluding to his membership in an airborne unit.

The documents received relative to Riddlebarger are attached to this report for further review, except for any prohibited LEADS/CCH reports which were disposed of according to applicable policies and procedures.
