**Narrative:**

On Tuesday, September 05, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chris Hamberg (SA Hamberg) compiled background information on Danny Berry (Berry), a subject involved in the incident on September 4, 2023. The information included researching past police reports involving the subject, searching criminal history records, court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit.

SA Hamberg reviewed the information and noted the following:
