Narrative:

On August 27, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Harasimchuk (Harasimchuk) completed a review of the Akron Police Department's (APD) body-worn camera (BWC) video files and dash camera video file for this case. BCI SA John Tingley had requested that SA Harasimchuk conduct a review of the BWC video files and dash camera video file in relation to the officer-involved critical incident that occurred on August 17, 2024, at 2215 East Avenue, Akron, Ohio 44314.

SA Harasimchuk located three BWC video files and one dash camera video file on the SIU shared drive in Reference Item A for this case file. The files were labeled as follows:
