On Thursday, January 22, 2026, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joshua Welty (SA Welty) received requested records and recordings from Pickaway County Sheriff's Office (PCSO) Captain Johnathan R. - 00:08 – Dispatcher requests any available unit to start towards 4800 Duvall Road, Lot 303, for an active 48 [sexual assault]. Male subject is still on scene. The female was able to lock him outside.
- 00:34 – [REDACTED] is dispatched to the call location. Dispatcher tells [REDACTED] there is a female advising that she was just 48 by [REDACTED] brother.
- 01:04 – Dispatcher informs responding law enforcement the male is trying to make entrance back into the residence.
- 01:31 – Dispatcher informs responding law enforcement they have report of shots fired at lot 292.
- 02:00 – Two radio channels patched together, SO 1 and SO 2. Channels placed into a 99 [emergency traffic only].
- 03:26 – Dispatcher informs Ashville units the male is trying to bust through the front door, and the caller is in the bathroom with the door locked.
- 03:39 – Officer radios he is holding a 40 [gun].
- 03:45 – Officer radios “gunpoint, he is not listening.”
- 04:15 – Dispatcher does a checkup. Officer indicates still at gunpoint.
- 05:48 – Officer radios to other officers letting them know there is a back door to the trailer to see if they can get the victim out.
- 06:18 – Officer radios “shots fired.”
- 06:36 – Officer requests the medic be sent it.
- 06:47 – Officer radios they have two code 40’s [gun] here.
- 07:16 – Officer radios “one male suspect, multiple gunshots to the chest and torso.”
- 08:24 – Officer radios entry has been made to the trailer.
- 10:44 – Officer radios they will be following Medic 801 to the emergency room.
- 10:54 – Officer radios they need an additional medic for a neighbor believed to have been hit by a stray.
- Between 12:28 to 14:00 – Officer requests the dispatcher to query the firearms. They provide the following serial numbers and models: Taurus (AHC801854),

- She reports Dalton is outside and she has locked the deadbolt.
- [REDACTED] reports Dalton has locked her and the roommate's daughter in the bathroom.
- She reports Dalton is banging on the bedroom window and screaming.
- Dispatcher asks [REDACTED] if she is injury. She replies, "I have a cut on my foot and on my face and the inside of me really hurt."
- Dispatcher asks if Dalton has assaulted her other than the rape. She replies, "he punched me in the ribs a couple times."
- [REDACTED] reports Dalton threatened to kill her brother and mom.
- A pop like sound is heard on the recording, followed by [REDACTED] saying, "I think he just broke my window," then followed by more pops.
- Dispatcher asks [REDACTED] if Dalton has a gun. She replies, "yes, he does. Fuck."
- Dispatcher asks [REDACTED] if Dalton shot at the house. She replies, "that might be what it is." She then states, "yeah, he's shooting at the house."
