Ohio Bureau of Criminal Investigation (BCI) Special Agent Matthew Armstrong previously executed a search warrant for Google records associated with Jayland Walker's (Walker) account (Jaylandwalker20@gmail.com). Agents later received those results.

The results included location data, Google searches and internet activity.

The location data was reviewed. An Investigative Report titled, "Google Location Mapping," was completed that illustrated Walker's activity for June 25th, 26th and 27th.

Special Agent Cory Momchilov completed a review for the remainder of Walker's Google activity and documented the following:
