**Narrative:**

On July 20, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Al Bansky (Bansky) received requested records and recordings from Austintown Police Lieutenant Jordan Yacvone. SA Bansky had previously requested all dispatch records and audio recordings. As a result of that request, the following items were received and reviewed:

The records indicated the dispatch information/notes during the course of the incident. SA Bansky noted the following information:

- Approximately 21:10:25, July 18, 2022, the caller's neighbor is acting strange again.
- Approximately 21:11:02, July 18, 2022, every time she opens the door, she cocks her gun.
- Approximately 21:11:17, July 18, 2022, the door has been wide open for the past few hours.
- Approximately 21:34:17, July 18, 2022, there is a gun.
- Approximately 21:35:32, July 18, 2022, Ian, calling 911, reference to officers yelling to drop the gun.
- Approximately 21:35:33, July 18, 2022, female came out in the hallway, screaming with a gun in her hand.
- Approximately 21:35:41, July 18, 2022, went back into the apartment with small son there.
