NARRATIVE

AGGRAVATED MENACING (N/S)

On 11/10/23 at approximately 1525 hours while in the company of P.O. Ratti #2318 and assigned to Z/C 4A21, we responded to a radio broadcast in relation to a person threatening with a weapon at premises # 7702 Spafford Rd. Below are the facts.

On our arrival, we spoke to [REDACTED] (Victim) who stated that she had been staying with Robert Perkins (Suspect) for the past couple days because she had been put out by her boyfriend and didn't have anywhere else to go. [REDACTED] continued to state that she reached out to Robert and he offered to give her a place to stay until she got things figured out. [REDACTED] continued to state that at about 1519 hours, and argument developed between her and Robert at which time he brandished a handgun and pointed it at her face while saying he was going to kill her and her cat if she didn't get out of his house. [REDACTED] then stated that because she feared for her life she ran out the house and called the police instantly.

Myself and P.O. Ratti then attempted to make contact with Robert by knocking on his door and announcing our office. Robert then came to the door where P.O. Ratti and I stated the allegations levied against him. Robert then stated that [REDACTED] came to him asking for a place to stay so he obliged her. Robert then stated that sometime earlier today [REDACTED] was locked up inside the upstairs room which he allowed her to stay in and was unresponsive when he knocked and called out to her. Robert then continued to state that he became worried because [REDACTED] is known to use drugs so he thought that she might have overdosed, hence he kicked in the door to see if she was indeed ok. Robert then mentioned that [REDACTED] was observed in the company of other people who he did not approve of being in his home and this is the reason he told her that she had to leave. Robert also stated that he told [REDACTED] that she could store her belongings in his greenhouse for a couple days until she made arrangements to retrieve them.

At the time of his report, [REDACTED] was offered assistance to be taken to a shelter and also to be seen by EMS, however she refused.
