Narrative:

On Thursday, January 8, 2021, Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Kevin Barbeau contacted the Athens Police Department (APD) to request a Domestic Violence report from 1995 involving Andre Hill. Andre was involved in an Officer-Involved Critical Incident when he had interaction with Columbus Police Officer (CPD) Officer Adam Coy and Officer Amy Detweiler at 1062 Oberlin Drive Columbus, Ohio on December 22, 2020. During said OICI Ofc. Coy fired his firearm striking Andre Hill, who eventually died from injuries he sustained.

SAS Barbeau received the attached APD reports and Athens Municipal court record(s) and the following should be noted:

- Date of offense: May 20, 1995
- Occurrence location: 1109 Carriage Hill Drive (Apartments), Athens, Ohio
- Offense: domestic violence
- Defendant: Andre Hill
- Victim: Michelle Hill (wife of defendant)
- Facts of arrest: physical altercation between Andre and Michelle, along with threats of violence
- Municipal Court document reads that Andre plead GUILTY on June 15, 1995

- You should file your claim with the Court of Claims, 65 East State Street, #1100, Columbus, OH 43215, or with the clerk of any Common Pleas Court in Ohio. Get claim forms from the police, sheriff, prosecutor, clerk of any Common Pleas Court or the Court of Claims. Social service agencies and hospitals may also have forms.
- Your claim is good only for out-of-pocket losses caused by the crime. Only losses for personal injury are covered under the program. Lost, stolen or damaged property is NOT covered.
- You are not required to have a lawyer, but you may pick your own if you think you need legal help. Lawyer fees will be paid by the State.

This date this cause came on for hearing/trial. Present in Court are Defendant, his/her attorney R. Rameck and G. McCarthy, Athens City Prosecutor, representing Plaintiff. Defendant, fully advised of his/her rights and acknowledging that his/her plea is made with full understanding of its ramifications enters a No Contest plea to the charge of a violation of Section 2919.25(A) ACC/ORC entitled DRIVING WHILE UNDER THE INFLUENCE OF ALCOHOL a 1st degree minor misdemeanor. offender (stipulated / actual)

Upon Defendant's plea and the statement of facts, the Court hereby accepts Defendant's plea and finds Defendant GUILTY and ORDERS the following sentence:

- 1) Fine in the amount of \$ 500
- 2) Jail term of 180 days in the Athens County Jail.
- 3) License suspension of 180 days/year(s), first 180 days no occupational privileges allowed.
- 4) 180 days of jail term (and/or) 150 dollars of fine (and/or) 180 days of license suspension are/is suspended/deferred on the following condition(s):
 - a) Defendant does not violate any local, state, or federal laws for 2 year(s);
 - b) Defendant attends and completes the Residential Treatment Program (RTP) within 180 days;
 - c) Defendant completes alcohol/drug evaluation at Health Recovery Services, Inc.; Hudson Health Center or other Court approved facility and abides by all counselling recommendations for 1 year(s);
 - d) Defendant abides by all counselling recommendations from Tri-County Mental Health or any Court approved mental health agency for 1 year(s);
 - e) All plates and registrations for any vehicles in the name of the defendant are ordered impounded for the BMV; 180 vehicle, license no. 180 VIN no. 180 which defendant was operating shall be immobilized for 180 days;
 - f) Defendant obtains a valid operators license within 180 days;
 - g) Defendant completes a one-day defensive driving program within 180 days;
 - h) Defendant makes restitution in: 180 the amount of \$ 180; (a reasonable amount to be provided) - by certified bank check or money order made payable to Prosecutor George McCarthy, Law Director's Office, 8 E. Washington Street, Athens, Ohio 45701 within 180 days.
 - i) Pursuant to ORC Section 4503.233 et seq., vehicle VIN. No. 180 is ordered forfeited.
- 5) Credit is hereby awarded for: 180 days served in the county jail, 180 days for Defendant's previously imposed license suspension.
- 6) Other DEFENDANT NOT TO HAVE ANY CONTACT
