**Narrative:**

On January 6, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Harasimchuk (Harasimchuk) reviewed one of the video files from the hidden camera that had been placed in the bedroom of 200 Cline Avenue, Mansfield, Ohio 44907 by Erin Brooks.

SA Harasimchuk located the hidden camera video file on the SIU shared drive in Reference Item J. The video file was titled as follows; **Item #20 - record - 2024-1019 - 02 - 32**.

SA Harasimchuk made a working copy of the video and placed it in a folder on his BCI-issued laptop. The working copy of the video file was used for review.

SA Harasimchuk imported the video file into Amped Replay for review.

**Item #20 - record - 2024-1019 - 02 - 32**

SA Harasimchuk reviewed the video file labeled, "Item #20 - record - 2024-1019 - 02 - 32." SA Harasimchuk noted the following information:

- The video-embedded timestamp dates were 2024-10-19.
- The video-embedded timestamp start time was 02:32:48.
- The video-embedded timestamp end time was 02:33:48.
- The video file was from a Wyze brand video surveillance camera.
- The camera was placed in a bedroom at 200 Cline Avenue, Mansfield, Ohio 44907.
