On Friday, May 20th, 2022, Ohio Bureau of Criminal Investigation (BCI) Crime Scene Unit (CSU) and Special Investigation Unit (SIU) were requested by the Miami Township Police Department (MTPD) regarding an officer involved shooting. It was reported MTPD officers were dispatched to a person shooting a gun in the area of 947 SR-28 and upon their arrival, a female identified as Camille Weems (Weems) shot at officers. One MTPD officer returned fire and struck Weems. Medical aid was rendered however Weems died from her injuries. CSU Special Agent (SA) Aja Chung was assigned by CSU Special Agent Supervisor (SAS) Lulla; and responded to MTPD to document the involved officers.

Miami Township Police Department

At 2009 hours, SA Chung photographed the involved officer and those officers that witnessed the incident as they were upon her arrival. MTPD Officer [REDACTED] ([REDACTED]), badge [REDACTED] was in his department issued uniform and advised he discharged his rifle that was left at the scene inside his cruiser [REDACTED]. SA Chung photographed Officer [REDACTED] pistol for documentation only. The pistol, a Glock 45 9x19 had a serial number: [REDACTED] and three full magazines (one in pistol, two on duty belt). SA Chung then photographed the following officers that witness the incident. Those MTPD officers included:

It should be noted, during the incident, MTPD Officers Morgan and Bunnell were in their full uniforms. MTPD officers Morgan and Bunnell partially disrobed after they returned to the station. MTPD Officer Morgan removed her uniform shirt, duty belt and bulletproof vest; MTPD Officer Bunnell removed his exterior vest. SA Chung observed a suspected bloodstain on MTPD Officer Morgan's duty pants, specifically the upper left leg area. The pants were collected as item 1.

Parking lot at 947 SR-28

SA Chung responded to 947 SR-28, Berry Lane Apartment complex and was updated by BCI SIU Agents already on scene. SA Chung was advised the shooting scene expanded from the parking lot of 947 SR-28 to Harkey's Motorsports, located across the street at 944 SR-28. At 2111 hours, SA Chung photographed the scene as it was upon arrival. The apartment complex consisted of two buildings with one main cul-de-sac driveway and parking lot area. Weems' body had been transported by medics and signs of medical intervention were still on scene.





Two MTPD cruisers remained on scene and were documented through photography. According to dashcam video, MTPD cruiser 1805 was not moved from its original position. MTPD cruiser 1805 was operated by Officer Bunnell and had a bicycle secured on the back. SA Chung located ballistic events (BE) on the bicycle and cruiser. On the rear tire rim of the bicycle, a circular shaped defect could be seen with the material pushed inward. The projectile perforated the rim, pushed the material outward and caused a misshaped hole, labeled BE 1.1. The projectile appeared to penetrate the rear passenger taillight that caused a misshaped hole (BE 1.2). SA Chung observed a bullet fragment within the taillight housing unit. The rear passenger taillight was removed and the fragment was collected as item 12. Another projectile perforated the bicycle's rear rack. Located on the left side (if seated properly on the bike) of the rack, a misshaped defect was labeled BE 2.0. The projectile caused shallow damage (BE 2.1) and no projectile recovered from BE 2.1. Cruiser [REDACTED] was operated by MTPD Officer [REDACTED]. SA Chung was advised MTPD cruiser [REDACTED] had been moved from its original position to make room for the medic.



SA Chung located the rifle [REDACTED] indicated he discharged on the front driver's seat. The rifle was found with the safety off (ready to fire). The rifle was a Sig Sauer M400, .223 caliber with S/N: [REDACTED]. There was one cartridge in the chamber and 22 cartridges in the seated magazine. The rifle (rendered safe), 23 cartridges and one magazine were packaged together as item 3.

SA Chung located and collected five .223 casings (items 4-8) with a "Speer" headstamp, on the driveway near the MTPD cruisers. The distance from the cruisers to the area where Weems was struck was between 70-75 feet. There was a large bloodstain on the driveway where Weems was laying. Near that bloodstain, a Taurus pistol was located on the east side of the driveway in the grass. The Taurus pistol was a 9mm G2C, with a serial number: ABA243918; the slide locked back with an empty magazine. The pistol and magazine were collected as item 9. A 9mm casing (item 10) with a Hornady headstamp was located where Weems was medically tended to. Another 9mm casing (item 11) was found on the driveway at the widening of the parking lot, near the private tow sign. Four items were located closer to the apartment buildings. At the front entryway to building B, a 9mm casing with a Hornady headstamp was found in some landscaping and collected as item 2. A wig with black curly hair was laying in the grass island and was collected as item 15. Near a parked maroon Chevrolet Impala (OH/JCF 6306), a .223 projectile (item 13) was found in the grass and near the front driver tire, a 9mm casing (item 14) with a Hornady headstamp was located.

SA Chung observed four ballistic events (BE) on a parked green pick up truck. It should be noted, SIU Agents received verbal consent from the owner to conduct the necessary search and documentation. The green and silver 2-door, Dodge Ram pick-up truck with an extended cab was parked, nose first, in parking spot 22 on the west side of the parking lot. All defects were located on the passenger side of the truck and were labeled BE 3.0 – BE 6.0, with a direction of exterior to interior. BE 3.0 and BE 4.0 were located in the center of the extended cab under the window and above the silver panel. BE 3.0 was a defect that perforated the trucks exterior metal and exited inside the rear cab that caused an irregularly shaped hole (BE 3.1). The projectile continued on from BE 3.1 and penetrated the back rest on the rear passenger side. The defect, BE 3.2, was revealed after SA Chung moved the secured baby seat from its position on the rear passenger side. No projectile was recovered from BE 3.2. The circular shaped defect, labeled BE 4.0, penetrated the metal and no projectile was recovered from that ballistic event. Above the front passenger door handle, SA Chung located a suspected ballistic defect (BE 5.0). The defect did not penetrate the material and no projectile was located. The front passenger side window was struck with a projectile on the middle-lower area of the window. SA Chung observed pulverized tempered glass on the driveway and front passenger side floorboard of the truck. Radial and conchoidal fractures were observed from two areas on the glass that remained in tact after the projectile perforated the glass. No projectile was recovered from BE 6.0.

Harky's Motorsports at 944 SR-28

At 0009 hours, SA Chung photographed Harky's Motorsports, the business located directly across the street from driveway of 947 SR-18. The front of the business faced SR-28 with the main entry door located on the east side of the building. The owner of the business provided MTPD officers with the key to unlock the business and gave consent to document and process the premises.

SA Chung observed the western most front window was struck with a projectile near the top right frame. The large misshaped hole perforated the exterior side of the double pane glass and was labeled BE 7.0. Radial and concentric fractures were observed and there appeared to be no damage to the metal frame at the point of impact. The glass was pushed outward on the interior side of the window that indicated a direction of exterior to interior. Tiny pieces of glass shards were observed throughout the showroom floor as well. Two projectiles were located inside the showroom. Directly in front of the damaged window, a suspected copper jacket (item 16) was located near a black Ducati motorcycle. Further inside the middle showroom near a black and green Kawasaki motorcycle, a suspected lead projectile was found and collected as item 17.



SA Chung concluded her investigation at 0033 hours as no other items of evidentiary value were found. The scene was released to MTPD who remained on scene for SA Chung's entire investigation. SA Chung drove to BCI offices in London, Ohio and secured the 17 items of evidence in the crime scene room temporary locker at 0310 hours.
