The Complaint having been filed on August 16, 1978, under Section 6111.07 and 6111.09 of the Ohio Revised Code, and Plaintiff and Defendants by their respective attorneys, having consented, without trial or adjudication of any issue of fact or law herein, to the entry of this Consent Judgment;

THEREFORE, before the taking of any testimony, upon the pleadings and upon the consent of the parties hereto, it is hereby ORDERED, ADJUDGED, and DECREED, as follows:

- (1) This Court has jurisdiction over the parties and the subject matter of this case. The Complaint states a claim upon which relief can be granted against Defendants under Sections 6111.07 and 6111.09 of the Ohio Revised Code.
- (2) The provisions of this Consent Judgment shall apply to and be binding upon the parties to this action, their agents, servants, employees, and successors; in addition, the provisions of this Consent Judgment shall apply to all persons, firms, corporations, agencies, and other entities have notice of this Consent Judgment and who are, or will be, acting in concert and privity with either party to this action or their agents, servants, employees, and successors.

- (3) As described in the Complaint, Defendants have violated Revised Code Section 6111.07 by failing to comply with the Director's Findings and Orders of May 25, 1976.
  - (4) Defendants are permanently enjoined to take the following actions:
  - (a) No later than March 31, 1981, enter into a sewage treatment agreement with the Village of Paulding for Sewer District No. 2 and submit it to Farmers Home Administration for approval.
  - (b) No later than March 31, 1981, secure all easements needed to construct the sewers, or in the event that one or more of the persons from whom easements are required refuse to voluntarily execute same, file and thereafter vigorously prosecute appropriate legal action to secure said easements.
  - (c) Within thirty days of approval of the sewage treatment agreement by the Farmers Home Administration and upon securing all the necessary easements, advertise for bids for construction of the sewers described in the detail plans submitted by the Paulding County Board of Commissioners to the Ohio EPA and approved by the latter on January 21, 1977 ("sewers").
  - (d) Within 45 days of advertising for bids, award contract for construction of the sewers.
  - (e) Within 150 days of awarding contracts, complete construction of the sewers.
- (5) Beginning April 1, 1981, the Defendants shall submit quarterly reports: to the Northwest District Office of the Ohio EPA describing their progress in complying with the terms of this Judgment.
- (6) Defendants shall take all other actions reasonably necessary to implement this Judgment.
  - (7) Defendants shall pay court costs.
