OHIO LAW ENFORCEMENT GATEWAY



The Ohio Law Enforcement Gateway is a free, web-based platform that allows law enforcement agencies to efficiently share criminal justice data. It provides investigative tools and training applications to help solve and prevent crime.

OHLEG applications include:

SEARCH ENGINE: This sophisticated tool is used to securely query — using a name, vehicle description, address, tattoo or image — numerous data sources. The app also includes a photo lineup wizard.

RECORDS MANAGEMENT SYSTEM: This customized system allows law enforcement agencies to store incident reports, issue citations and manage property room evidence. It allows for free, easy data export to the Ohio Incident-Based Reporting System and the Ohio Local Law Enforcement Information Sharing Network, also known as OLLEISN.

LABORATORY ONLINE: This app allows county prosecutors to securely track the testing status and results of DNA and other types of evidence that local law enforcement agencies submit to the Ohio Attorney General's Bureau of Criminal Investigation.

LABORATORY EVIDENCE PRE-LOG AND INQUIRY: This app allows an OHLEG user to complete BCI's evidence submission paperwork in advance and check on completion status.

OHLEG SWIFT SHARE: This app enables local law enforcement agencies in Ohio to securely share criminal investigative information. Swift Share information can assist officers in making accurate and timely decisions and is most effective in multijurisdictional cases.

CONCEALED-CARRY WEAPON STATS: This app lists statistics and reports on CCW permits in each county, as well as certified instructors.

RX PATTERN ANALYSIS TRACKING ROBBERIES AND OTHER LOSSES: This app provides a link to RxPatrol, a nationwide searchable database of prescription-related crimes. The database can be used to identify trends, support criminal cases and combat the abuse of prescription drugs.

MISSING CHILDREN CLEARINGHOUSE: This app is a link to the statewide repository for information on missing children's cases reported to the National Crime Information Center. Ohio law enforcement officers can share case information and conduct research.

LAW ENFORCEMENT REPORTS: Monthly and annual reporting for Domestic Violence, Human Trafficking and Distracted Driving can be done via OHLEG.

NEGATIVE DNA FLAG OFFENDER REPORT: This app helps law enforcement officers see which DNA collections their agency has missed sending to BCI. Officers can select a date range and their agency's Originating Agency Identifier number and run a report that lists adults with felony arrests who have yet to provide a DNA sample to the Combined DNA Index System, better known as CODIS.

SCHOOL SAFETY PLANS: This app provides comprehensive safety plans that take into account threats and hazards for each school. Building floor plans that identify key infrastructure are among included information.
