- ✓ Is an additional data source in the Ohio Law Enforcement Gateway's search engine that provides a snapshot of another local agency's incident.

## OHLEG SWIFT RMS

Since taking office, Ohio Attorney General Dave Yost has made it a priority to upgrade OHLEG to better serve law enforcement agencies statewide at no cost to them. The upgrades allow for easy electronic data export to OIBRS, DPS and SWIFT Share. Other features:

- **Case Management** allows cases to be generated and linked to reports. It can also track expenses, notes, case history and follow-up tasks, and produce a case map and link analysis.
- **Traffic Crash Report** is Ohio DPS-compliant, allowing for submissions to state and integrated Easy Street Draw for creating crash diagrams.
- **Citations** facilitates the creation of Ohio DPS-compliant eCitations or digital tracking of paper citations. eCitations can be submitted to courts that have a DPS-compliant citation module in management systems.
- **Property Room** offers full control of property-room locations for both temporary and permanent storage. As property-related actions are performed, it automatically uses signatures to keep a chain of custody. Using bar-code scanners, it quickly finds and opens property and/or assigns property to a location. It also has a full audit function.

**Coming soon:** An interface for Property Room to Laboratory Pre-Log.

- **Incident reports** are OIBRS-compliant with automated monthly OIBRS submissions. With built-in OIBRS validation, reports can be validated in real time. Incident reports are integrated with the property room and can be assigned to officers for follow-up. Enhance redaction capabilities include sealing and expungements.

**Coming soon:** Submissions to Matrix.

- **Vacation Watch** allows an agency to document citizen requests for a property check while they are away. Officers can document each time a property is checked and generate a call record from the check with details automatically populated into the call record.
- **Patrol Log** allows officers to document daily activity – information that can be customized by each agency. Reports can be generated from these logs.
