Narrative:

On Thursday, November 17, 2022, the Bureau of Criminal Investigation responded to the Ross County Sheriff's Office (RCSO) located at 28 North Paint St., Chillicothe, Ohio. BCI was requested to investigate an Officer-Involved Critical Incident (shooting) that occurred on this date between RCSO Sergeant Eric Kocheran (involved officer) and Nicholas Mitchell (involved party). During an interaction between Sgt. Kocheran and Mitchell there was an exchange of gunfire and Sgt. Kocheran was injured and transported to Grant Medical Center (Columbus). Mitchell was transported Adena Medical Center were he died.

Following the initial on-scene investigation, BCI was informed Mitchell had interaction with law enforcement authorities in Jackson, Ohio. SAS Kevin Barbeau followed up on this information and contacted Jackson County Sheriff's Office (JCSO), Jackson City Police Department (JPD), and the Jackson County Prosecutor's Office requesting documentation of their interactions with Mitchell.

JCSO provided SAS Barbeau, via e-mail, with the attached report (20-3355-SW). SAS Barbeau reviewed the report and learned Mitchell was arrested for aggravated menacing on September 28, 2020 within Jackson County for his interaction/confrontation of three (3) adult individuals. Mitchell fled the scene and was later arrested by JCSO. Per the report, Mitchell pointed a firearm at individuals and he later admitted to the same.

SAS Barbeau also received and reviewed the JCSO jail booking documentation via fax. It would appear Mitchell was booked into the JCSO jail on the same date on three (3) charges of aggravated menacing. The booking documents should be reviewed for additional details but the following should be noted:

The Jackson County Prosecutor's Office confirmed the cases and guilty plea against Mitchell and they added his probation was terminated by the judge on September 15, 2022. See attached cases and dockets for additional details.

There were no reported interactions with Mitchell and JPD.




